MEMBERSHIP

Membership is open to any company or individual that is engaged in the primary or secondary processing of timber or provides consulting or ancillary services to those sectors.

Membership is renewed annually on 1 July each year.

FULL MEMBERSHIP

Full member – a company which is engaged in primary or secondary processing of timber (hardwood and softwood)

ASSOCIATE MEMBERSHIP

Associate member – a company or individual who is engaged in further processing of timber, a service provider to the industry or a consultant or merchant in the industry.

- Service Provider (machinery, chemicals, merchant etc.)
- Further Processor/User (frame and truss, flooring, power poles etc.)
- Consultant (forestry, marketing etc.)
- Contractors or Harvest and Haul is open to any company engaged in harvesting or haulage of timber.
- Private Native Forest Owner/Landholder
- Energy/Heat Plants using forest residues
